# BOOKING TERMS AND CONDCTIONS

- A By booking or participating in a tour and any related products or services (a “Tour”) with Aussieskier Adventures Pty Ltd ACN 620 884 693 (“Aussieskier Adventures”), you (“you”) agree to these Terms & Conditions (the “Terms”).
- B By booking or participating in a Tour you acknowledge that you have read, understand and agree to be bound by these Terms. If you make a booking on behalf of other participants, you guarantee that you have the authority to accept and do accept these Terms on behalf of the other participants in your party.

## 1 THE BOOKING CONTRACT

---

### 1.1 YOUR BOOKING

- (a) Your booking is confirmed and a contract exists when Aussieskier Adventures issues a written confirmation after receipt of the applicable deposit amount. Please check your confirmation carefully and report any incorrect or incomplete information to Aussieskier Adventures immediately. Please ensure that names are exactly as stated in the relevant passport.
- (b) You must be at least 18 years of age to make a booking. You agree to provide full, complete and accurate information to Aussieskier Adventures.
- (c) All Tour participants must sign a Traveller Participation Waiver.

### 1.2 BOOKING ON BEHALF OF OTHERS

- (a) By booking on behalf of other participants, you are deemed to be the designated contact person for every participant included on that booking. This means that you are responsible for making all payments due in connection with your Tour booking, notifying Aussieskier Adventures if any changes or cancellations are required and keeping your party informed.
- (b) By booking on behalf of another person or persons, you represent and warrant that you have obtained all required consents. You are responsible for verifying that any information you provide on behalf of another participant is complete and accurate and Aussieskier Adventures will under no circumstances be liable for any errors or omissions in the information provided to complete a booking.

## 2 YOUR REQUIREMENTS

---

### 2.1 MEDICAL INFORMATION

- (a) You must provide any medical information reasonably requested by Aussieskier Adventures.
- (b) Aussieskier Adventures reserves the right to request further information or professional medical opinions where necessary, as determined in its discretion, for your safety or the safe operation of a Tour.
- (c) Aussieskier Adventures reserves the right to deny you permission to travel or participate in any aspect of a Tour at any time and at your own risk and expense where Aussieskier Adventures determines that your physical or mental condition renders you unfit for travel or you represent a danger to yourself or others.
- (d) Pregnancy is considered a medical condition and must be disclosed to Aussieskier Adventures at the time of booking. Aussieskier Adventures may refuse

to carry pregnant women over 24 weeks. Aussieskier Adventures may refuse to carry anyone with certain medical conditions if reasonable accommodation or alternatives cannot be arranged.

- (e) In the event that you do not provide medical information reasonably required by Aussieskier Adventures for any reason by the deadline indicated above, Aussieskier Adventures reserves the right to cancel your booking and all applicable cancellation fees will apply.
- (f) You are responsible for assessing whether a Tour is suitable for you. You should consult your physician to confirm your fitness for travel and participation in any planned activities. You should seek your physician's advice on vaccinations and medical precautions. Aussieskier Adventures does not provide medical advice. It is your responsibility to assess the risks and requirements of each aspect of the Tour based on your own unique circumstances, limitations, fitness level and medical requirements.
- (g) Travel with Aussieskier Adventures may involve medical evacuation and extended transfer time between regions to access medical care. The condition of medical facilities in the countries you may visit on your Tour varies and Aussieskier Adventures makes no representations and gives no warranties in relation to the availability or standard of medical facilities in those regions.

## **2.2 AGE REQUIREMENTS**

Unless otherwise indicated in the Tour description or by Aussieskier Adventures, the minimum age for any participant travelling on any Tour is 18 years old.

## **2.3 SPECIAL REQUIREMENTS**

Any special requirements must be disclosed to Aussieskier Adventures at the time of booking. Aussieskier Adventures will use reasonable efforts to accommodate special requirements or requests but this is not always possible given the nature of the destinations visited and availability of options outside a planned itinerary. Certain activities may be inaccessible to you if your mobility is limited in any way. All food allergies and dietary restrictions must be disclosed to Aussieskier Adventures at the time of booking but Aussieskier Adventures cannot guarantee that dietary needs or restrictions can be accommodated. Any special requests or requirements do not form part of these Terms or the contract between you and Aussieskier Adventures and Aussieskier Adventures is not liable for any failure to accommodate or fulfil such requests.

## **2.4 MANDATORY INSURANCE REQUIREMENTS**

YOU MUST HAVE TRAVEL INSURANCE WITH A MINIMUM MEDICAL, EVACUATION AND REPATRIATION COVERAGE OF US\$500,000 covering all applicable dates of travel with Aussieskier Adventures. This insurance must cover personal injury and emergency medical expenses. You are strongly recommended to extend your coverage to include cancellation, curtailment, and all other expenses that may arise as a result of loss, damage, injury, delay or inconvenience while traveling. You acknowledge that insurance coverage is not included in the cost of any Tour offered by Aussieskier Adventures and you are required to obtain separate coverage at an additional cost. It is your responsibility to ensure that you have sufficient coverage and comply with the terms of the applicable insurance plans. You are responsible for advising your insurer of the type of travel, destination(s) and activities included in your booking so that the insurer may provide appropriate coverage.

## **2.5 TRAVEL DOCUMENTS**

It is your responsibility to obtain information and to have in your possession all the required documentation and identification required for entry, departure and travel to each country or region. This includes a valid passport and all travel documents required by the relevant governmental authorities including all visas, permits and certificates (including but not limited to vaccination or medical certificates) and insurance policies. You must have a passport that is valid 6 months after the last date of travel with Aussieskier Adventures as set out on your itinerary. You accept full responsibility for obtaining all such documents, visas and permits prior to the start of the Tour, and you are solely responsible for the full amount of costs incurred as a result of missing or defective documentation. You agree that you are responsible for the full amount of any loss or expense incurred by Aussieskier Adventures that is a direct result of your failure to secure or be in possession of proper travel documentation. Aussieskier Adventures does not provide advice on travel documents and makes no representations or warranties as to the accuracy or completeness of any information provided on visas, vaccinations, climate, clothing, baggage, or special equipment and you agree that Aussieskier Adventures is not responsible for any errors or omissions in this information.

## **3 PRICING**

---

### **3.1 TOUR PRICE**

- (a) The published price of the Tour and any products or services offered by Aussieskier Adventures is subject to change at any time, before or after booking confirmation, up to 60 days before departure. Tours are priced and advertised exclusive of applicable sales taxes. After a confirmation invoice has been issued by Aussieskier Adventures, Aussieskier Adventures reserves the right to impose surcharges on any products or services booked for reasons arising from increases in transportation costs, fuel costs, dues, taxes or fees chargeable for services such as landing taxes or embarkation or disembarkation fees at ports and airport charges, local operator costs, currency and exchange fluctuations, increases in taxes, or government action which impacts the price of the applicable products or services; provided however, Aussieskier Adventures will only do so where the increase in question is greater than 2% of the original price paid for the products or services (excluding add-ons, insurance, and taxes). Upon learning of the necessity to impose a surcharge in accordance with this section Aussieskier Adventures will provide notice to you as soon as reasonably possible.
- (b) Where the increase in price is greater than 7% of the original price of the applicable products or services (excluding add-ons, insurance and taxes), you may choose to either:
  - (i) cancel the applicable booking without incurring any penalty; or
  - (ii) accept the change of price.
- (c) You must notify Aussieskier Adventures of your choice within 7 days of receipt of notice of the increase or you will be deemed to have accepted the price change and will be liable for payment of the increase.
- (d) From time-to-time Aussieskier Adventures may offer reduced pricing on certain products or services. Reduced pricing applies only to new bookings. Bookings where payment of at least a deposit has been received by Aussieskier Adventures are not entitled to reduced pricing.

### **3.2 VALIDITY**

- (a) All dates, itineraries and prices of Tours are subject to change at any time and the current price will be quoted and confirmed at the time of booking, subject to any surcharges that may be levied in accordance these Terms.
- (b) You acknowledge that you are responsible for keeping up to date on the specific details of your Tour and any other products or services, including, but not limited to checking Aussieskier Adventures's website <http://adventures.aussieskier.com> at least 72 hours prior to departure as minor changes may have been made after the time of booking.

### **3.3 DETAILS REQUIRED FOR BOOKING**

As a condition of booking, you must provide the information requested by Aussieskier Adventures along with final payment. If you fail to provide all required information prior to the date on which full payment is due, an administrative fee will be charged for any costs incurred by Aussieskier Adventures as a result of your failure to provide the required information. If you fail to supply information required by Aussieskier Adventures for air tickets, permits, or other inclusions, you will also be liable for any costs, fees or losses including failure to obtain or provide that inclusion. In the event that you fail to supply information required by Aussieskier Adventures, Aussieskier Adventures also reserves the right to treat your booking (or the relevant component of your booking) as cancelled and levy any cancellation fees deemed reasonable by Aussieskier Adventures, in its sole discretion. The information required by Aussieskier Adventures will vary by Tour and will be communicated to you or to Aussieskier Adventures's authorized agent during the booking process. Aussieskier Adventures will not be held responsible for any fees you incur as a result of errors, omissions, inaccuracies, late, misplaced or otherwise incomplete information you have provided.

### **3.4 DEPOSITS**

At the time of booking, a non-refundable deposit of 20% of the Tour price per person is due to Aussieskier Adventures. If the booking is made 90 days or less prior to departure, full payment is due at the time of booking. The non-refundable deposit should be sent to Aussieskier Adventures.

### **3.5 FINAL PAYMENT**

- (a) The confirmation sent by Aussieskier Adventures will contain details of final payment required for any booking. Payment of the balance of the price for any products or services booked is due 90 days before the departure date of the first product or service included in the applicable booking. If full payment is not received by the applicable due date, Aussieskier Adventures may, at its sole discretion, change the rate payable for the booking, or treat the booking as cancelled and retain the deposit paid on booking as a cancellation fee. If a booking is made less than 90 days before the departure date of the first product included in the applicable booking, then the full amount must be paid at the time of booking. If, for any product or service booked, payment terms differ from those outlined in this section, the applicable terms will be communicated to you prior to booking and will also be detailed on the applicable invoice.
- (b) Aussieskier Adventures is not responsible for any charges levied by third parties or financial institutions and payable by you as a result of credit card or other payment transactions and will not refund or return any fees charged by third parties or financial institutions in connection with payments made by you to Aussieskier Adventures.

### **3.6 AIRFARE**

Tour prices do not include international or other airfare.

## **4 CANCELLATION**

---

### **4.1 BY THE PARTICIPANT**

- (a) You may cancel your booking by notifying Aussieskier Adventures. Cancellation fees, if any, will be determined with reference to the date on which notice of cancellation is received by Aussieskier Adventures and are expressed as a percentage of the total price paid for the cancelled Tour, product or service (excluding any insurance products).
- (b) Cancellation of a Tour:
  - (i) Cancellation received 90 days or more before departure of first product or service in relevant booking: Deposit will be held by Aussieskier Adventures in accordance with these Terms, the remainder of the payments made to Aussieskier Adventures in respect of the cancelled product will be refunded.
  - (ii) Cancellation received 89-60 days before departure of first product or service in relevant booking: an amount equal to [50%] of the remainder of the payments made to Aussieskier Adventures in respect of the cancelled Tour will be refunded.
  - (iii) Cancellation less than 60 days before departure of first product or service in relevant booking: Deposit will be held by Aussieskier Adventures in accordance with these Terms, and no further refund will be payable.

### **4.2 BY AUSSIESKIER**

- (a) If a Tour is cancelled by Aussieskier Adventures before the date of departure for reasons other than Force Majeure and the cancellation is not caused by your fault or negligence, you will have the choice of accepting from Aussieskier Adventures:
  - (i) a substitute Tour of equivalent or superior value; or
  - (ii) a substitute Tour of lesser value if no Tour of equivalent or superior value is reasonably available and to recover from Aussieskier Adventures the difference in price between the price of the Tour originally purchased and the substitute Tour; or
  - (iii) a full refund of all monies paid for the cancelled Tour.
- (b) Aussieskier Adventures is not responsible for any incidental expenses or consequential losses that you incur as a result of the cancelled booking including visas, vaccinations, non-refundable flights or rail, non refundable car parking or other fees, loss of earnings, or loss of enjoyment, Aussieskier Adventures reserves the right to issue a full refund in lieu of the choices above, in its sole discretion. Where a significant element of a Tour as described cannot be provided after departure, Aussieskier Adventures will make suitable alternative arrangements where possible. If it is not possible to provide a suitable alternative or if you reasonably reject any suitable alternatives, Aussieskier Adventures may provide you with a refund for unused products or services as determined in its discretion.

## 5 TOUR FLEXIBILITY & CHANGES

---

### 5.1 FLEXIBILITY & UNUSED SERVICES

- (a) You acknowledge that the nature of adventure travel requires flexibility and acknowledges that they will permit reasonable alterations to products, services or itineraries by Aussieskier Adventures. The route, schedules, accommodations, activities, amenities and mode of transportation are subject to change without notice due to unforeseeable circumstances or events outside the control of Aussieskier Adventures (including but not limited to Force Majeure, snow and weather conditions, third party suppliers, avalanche conditions, transportation delay and road closures illness, mechanical breakdown, flight cancellations, strikes, political events and entry or border difficulties).
- (b) No reimbursements, discounts or refunds will be issued for services that are missed or unused after departure due to no fault of Aussieskier Adventures, including your removal from a Tour because of your negligence or breach of these Terms.

### 5.2 CHANGES

- (a) Aussieskier Adventures may modify your itinerary where reasonably required in its sole discretion. If Aussieskier Adventures makes a change affecting at least one in three full days of the itinerary or which materially affects the character of a product or service in its entirety (a "Material Change"), Aussieskier Adventures will provide notice to you as soon as reasonably possible, provided that there is sufficient time to do so before departure. If a Material Change is made more than 14 days before departure, you may choose to:
  - (i) accept the Material Change and proceed with the amended product or service;
  - (ii) book another product or service of equal or greater value, if available (you will be responsible for paying any difference in price); or
  - (iii) book another product or service of lesser value, if available (with a refund payable to you for the difference in price); or
  - (iv) cancel the amended product or service and receive a full refund for the land-only portion of the applicable product or service (a refund is not available for other products or services booked which are not subject to a Material Change).
- (b) You must notify Aussieskier Adventures of your choice within 7 days of receiving notice or you will be deemed to accept the amended itinerary.
- (c) Once a Tour has departed, itinerary changes may be necessary as a result of unforeseen circumstances, operational concerns, or concerns for your health, safety, enjoyment or comfort. Any changes are at the discretion of Aussieskier Adventures. You acknowledge that you must have reasonable financial resources to cover incidental expenses during all travel with Aussieskier Adventures, whether or not such expenses arise from a change of itinerary, and Aussieskier Adventures is not liable for your failure to prepare adequately for travel and unforeseen circumstances which may arise during travel. Aussieskier Adventures will not be liable for any indirect and or consequential losses associated with any changes to a booking or itinerary.
- (d) You are responsible for ensuring that information provided to Aussieskier Adventures is accurate and up-to-date. Any changes to your name on any booking are subject to Aussieskier Adventures's approval. Any changes to a booking



depend on availability and are subject to Aussieskier Adventures's approval and these Terms. Any extra costs incurred for making the change will be charged to you along with an administrative fee. Cancellation of any Tour, product or service included in a booking will not be considered a change for purposes of this section and will be governed by the applicable cancellation terms. No changes are permitted to any booking within 10 days of departure of the first product or service on the applicable booking.

## **6 ACCEPTANCE OF RISK**

---

### **6.1 YOUR ACKNOWLEDGEMENT**

- (a) You acknowledge that adventures travel and the products and services offered by Aussieskier Adventures may involve a significant amount of risk to your health and safety. By traveling with Aussieskier Adventures you acknowledge that you have considered any potential risks to health and safety. You hereby assume responsibility for all such risk and releases Aussieskier Adventures from all claims and causes of action arising from any losses, damages or injuries or death resulting from risks inherent in travel, including adventure travel specifically, visiting foreign destinations, and participating in adventurous activities such as those included in Tour itineraries or otherwise offered by Aussieskier Adventures.
- (b) You acknowledge that the degree and nature of personal risk involved depends on the products or services booked and the location(s) in which a product or service operates, and that there may be a significant degree of personal risk involved in participating, particularly participating in physical activities, travel to remote locations, participation in "extreme sports" or other high-risk activities. Standards of hygiene, accommodation and transport in certain countries where Tours take place are often lower than the standards you may reasonably expect in your home country or region. You agree that Aussieskier Adventures is not responsible for providing information or guidance with respect to local customs, weather conditions, specific safety concerns, physical challenges or laws in effect in any locations where a Tour, product or service is operated. You acknowledge you have considered the potential risks, dangers and challenges and your own personal capabilities and needs, and you expressly assume the risks associated with travel under such conditions.
- (c) You must at all times strictly comply with all applicable laws and regulations of all countries and regions. Should you fail to comply with the above or commit any illegal act when on Tour or, if in the opinion of Aussieskier Adventures (acting reasonably), your behaviour is causing or is likely to cause danger, distress or material annoyance to others, Aussieskier Adventures may terminate your travel arrangements on any product or service immediately at your expense and without any liability on Aussieskier Adventures's part. You will not be entitled to any refund for unused or missed services or costs incurred as a result of termination of your travel arrangements, including, without limitation, return travel, accommodations, meals, and incidentals.
- (d) You are responsible for any costs (including repair, replacement and cleaning fees) incurred by Aussieskier Adventures or Aussieskier Adventures's suppliers for property damage, destruction or theft caused by you while on a Tour. You agree to immediately report any pre-existing damage to a representative of Aussieskier Adventures and staff of the accommodation, transportation service, or facility as soon as possible upon discovery.
- (e) You agree to take all prudent measures in relation to your own safety while on Tour including, but not limited to, the proper use of safety devices (including

seatbelts, harnesses, flotation devices and helmets) and obeying all posted signs and oral or written warnings regarding health and safety. Neither Aussieskier Adventures nor its Third Party Suppliers (as defined herein) are liable for loss or damages caused by your failure to comply with safety instructions or warnings.

- (f) You agree to bring any complaints to Aussieskier Adventures as soon as possible in order to provide Aussieskier Adventures with the opportunity to properly address such complaint. You agree to inform your tour leader, another representative of Aussieskier Adventures or Aussieskier Adventures's customer service department directly. Aussieskier Adventures assumes no liability for complaints that are not properly brought to the attention of Aussieskier Adventures and cannot resolve or attempt to resolve complaints until proper notice is provided. Any complaint made after the completion of a Tour must be received in writing by Aussieskier Adventures within 30 days of the last day of travel of the booking in question.

## **7 OPTIONAL EXTRAS**

---

- (a) "Optional Extras" refers to any activity, transportation, meal, product or service not expressly included in the Tour itinerary or price of the Tour and do not form part of the Tour. You agree that any assistance given by Aussieskier Adventures's representative(s) in arranging, selecting, or booking, any Optional Extras is purely at your request and Aussieskier Adventures makes no warranties and expressly disclaims any liability whatsoever arising from participation in Optional Extras or any information provided by any representative of Aussieskier Adventures regarding any Optional Extras. You release Aussieskier Adventures from all claims and causes of action arising from any damages, loss of enjoyment, inconvenience, or injuries related to or arising from participation in or booking of Optional Extras.
- (b) You acknowledge and agree that any liability for loss, damages, death, personal injury, illness, emotional distress, mental suffering or psychological injury or loss of or damage to property associated with Optional Extras is the sole responsibility of the third party providing that service or activity.

## **8 LIABILITY**

---

### **8.1 THIRD PARTY SUPPLIERS**

- (a) Aussieskier Adventures makes arrangements with accommodation providers, activity providers, airlines, cruise lines, coach companies, transfer operators, shore excursion operators, tour and local guides, and other independent parties ("Third Party Suppliers") to provide you with some or all of the components of your booking. Third Party Suppliers may also engage the services of local operators and sub-contractors. Although Aussieskier Adventures takes all reasonable care in selecting Third Party Suppliers, Aussieskier Adventures is unable to control Third Party Suppliers, does not supervise Third Party Suppliers and therefore cannot be responsible for their acts or omissions. Any services provided by Third Party Suppliers are subject to the terms and conditions imposed by these Third Party Suppliers and their liability is limited by their tariffs, conditions of carriage, tickets and vouchers and international conventions and agreements that govern the provision of their services. These may limit or exclude liability of the Third Party Supplier. You acknowledge that Third Party Suppliers operate in compliance with the applicable laws of the countries in which they operate and Aussieskier Adventures does not warrant that any Third Party Supplier is in compliance with the laws of your country of residence or any other jurisdiction.

- (b) Aussieskier Adventures is not liable for the acts or omissions, whether negligent or otherwise, of Third Party Suppliers or any independent contractors.

## **8.2 AUSSIESKIER ADVENTURES'S LIABILITY**

Aussieskier Adventures and its parents, subsidiaries and their respective employees, affiliates, officers, directors, successors, representatives, and assigns shall not be held liable for:

- (a) Any damage to, or loss of, property or injury to, or death of, persons occasioned directly or indirectly by an act or omission of any other provider, including but not limited to any defect in any aircraft, watercraft, or vehicle operated or provided by such other provider; and
- (b) Any loss or damage due to delay, cancellation, or disruption in any manner caused by the laws, regulations, acts or failures to act, demands, orders, or interpositions of any government or any subdivision or agent thereof, or by acts of God, strikes, fire, flood, war, rebellion, terrorism, insurrection, sickness, quarantine, epidemics, theft, or any other cause(s) beyond their control. You waive any claim against Aussieskier Adventures for any such loss, damage, injury, or death; and
- (c) Any claims, losses, damages, costs or expenses arising out of inconvenience, loss of enjoyment, upset, disappointment, distress or frustration, whether physical or mental, resulting from the act or omission of any party other than Aussieskier Adventures and its employees.
- (d) In the event that any loss, death, injury or illness is caused by the negligent acts or omissions of Aussieskier Adventures or of the Third Party Suppliers of any services which form part of the booking contract then Aussieskier Adventures limits its liability, where applicable by all applicable international conventions.
- (e) Notwithstanding anything to the contrary elsewhere in these Terms, Aussieskier Adventures will not in any circumstances be liable to you for any loss or anticipated loss of profit, loss of enjoyment, loss of revenue, loss of use, loss of contract or other opportunity nor for any other consequential or indirect loss or damage of a similar nature.
- (f) For claims not involving personal injury, death or illness or which are not subject to the Conventions referred to above, any liability Aussieskier Adventures may incur for the negligent acts or omissions of its suppliers will be limited to a maximum of the price which you paid for the applicable Tour, not including insurance premiums and administration charges. Where this relates to loss or damage to luggage and other personal possessions then Aussieskier Adventures liability will not exceed AUD\$1,000. Aussieskier Adventures will not at any time be liable for any loss of or damage to valuables of any nature. You agree that you will be precluded from making a double recovery by making the same claims and seeking recovery against Aussieskier Adventures and its suppliers, contractors or other third parties.

## **9 FORCE MAJEURE**

---

Aussieskier Adventures will not be liable in any way for death, bodily injury, illness, damage, delay or other loss or detriment to person or property, or financial costs both direct and indirect incurred, or for Aussieskier Adventures failure to commence, perform or complete any duty owed to you if such death, delay, bodily injury (including emotional distress or injury), illness, damage or other loss or detriment to person or property is
